AUTHORIZATION TO CHARGE TRUSTEE FEES TO A CREDIT CARD.

With reference to the Agreement providing for use of that certain credit card number referred to hereinbelow, which Agreement was entered into by and between the undersigned and the issuer set forth therein, I hereby request and expressly direct the aforementioned issuer to pay to BBVA Bancomer Servicios, S.A. Institucion de Banca Multiple, Grupo Financiero BBVA Bancomer, Direccion Corporativa Fiduciaria, with charge to the account of the above-mentioned card, such amounts as requested in writing by the relevant Bank in connection with amounts used to obtain the corresponding permit from the Department of Foreign Affairs and any and all expenses incurred pursuant to the Foreign Investment Law and its applicable Regulation, which amounts to this date are equivalent to [redacted] US Dollars, (USD \$ [redacted]) or its equivalent amount in Mexican pesos, [redacted] 00/100 Mexican Pesos (\$ [redacted]).

Further, I hereby authorize and direct the issuer mentioned below to charge to my credit card the following amounts:

- A) For expenses incurred in connection with paper work and filings to obtain the relevant permit from the Department of Foreign Affairs and to record the respective trust with the National Registry of Foreign Investment, an amount equivalent to [redacted] USCy (USD \$ [redacted]) or any equivalent amount in Mexican Pesos.;
- B) For initial fees and fees corresponding to the first year of administration of trust, an amount equivalent to [redacted] USCy (USD \$ [redacted]) or any equivalent amount in Mexican Pesos; and
- C) For subsequent annual fees derived from the administration of trust, an amount equivalent to [redacted] USCy (USD \$ [redacted]) or any equivalent amount in Mexican Pesos.

Provided that the corresponding charges shall be deemed withdrawals from that certain credit granted by the issuer to the undersigned, pursuant to the relevant agreement.

I further agree that performance of the directions referred to above shall be subject to the following rules:

- A) In accordance with applicable policies, all payments due in connection with my account shall have been made; otherwise, the issuer shall ignore the aforementioned directions; and
- B) All payments made hereunder shall be without liability to BBVA Bancomer Servicios, S.A. Institucion de Banca Multiple, Grupo Financiero BBVA Bancomer, Direccion Fiduciaria.

Furthermore, I hereby represent that I am aware and agree that, in any event of termination or cancellation of the relevant agreement providing for the use of the above-mentioned credit card, whereupon my card will be cancelled, the issuer shall immediately refrain from providing the service set forth herein, with charge to the account of my credit card.

The service referred to in the preceding paragraph shall also be terminated if I fail to timely pay all charges reflected on my credit card statement of account, whether or not related to the service requested herein.

This authorization shall remain in full force and effect unless and until 30-calendar day prior notice to the contrary is given. In any event of expiration or renewal of my plastic card, I hereby agree to deliver to BBA Bancomer Servicios S.A., a photocopy of any new plastic card (both sides), to its address designated below.
